Requested Deliverables and Submission

REQUESTED DELIVERABLES

Note: all the following requests, notes and elements are mandatory and their absence or non-compliance with the requirements entails the total non-admissibility of the proposal.

The required design documents and materials are in digital format and meet the following characteristics:

No. 1 digital model in the *BIM-compliant IFC2x3* format (Industry Foundation Classes) **of the housing unit** chosen from the two proposed types. The housing unit can be contextualized within a **plan-type or building-type model** with any level of detail.

No. 1 digital model in the *BIM-compliant IFC2x3* format (Industry Foundation Classes) **of the exterior of the building** to which the housing unit belongs. The housing unit model can be part of the building model (or even coincide with it in the case of a single house, a cottage, etc.) or it can be separate from it.

The elements required in the tender regulations must be present and identifiable without uncertainty in the IFC models. Furthermore, the images and videos extracted from the model itself must be easily traceable to the model itself

No. 1 JPG/PNG image in high definition (300dpi) representative of the proposal and usable in communication as its avatar. This image can be post-produced with photo editing tools while maintaining an evident correlation with what is present in the 3D models of the proposal.

JPG/PNG images and Videos (panoramic, walk-through) in any number of the housing unit, the building that contains it and other representative and significant elements of the proposal extracted (and possibly post-processed) from the 3D models submitted.

No. 1 List of furnishing and finishes used in the proposal in Adobe PDF format.

No. 1 Design Report on an ISO A4 page in Adobe PDF format containing:

- **Alphanumeric Code** released to the competitor following the registration procedure.
- **Name** of the proposal
- **Description** of the proposal

COMMON TECHNICAL ASPECTS

- **Language: all the deliverables must be in Italian or in English. Other languages are not allowed.**
- The deliverables cannot contain anything that could lead to the identification of the author.
- It is the responsibility of the competitors that the graphic representation of the proposal is qualitatively adequate to be reproduced both digitally and on paper.

SUBMISSION OF THE DELIVERABLES AND CONFIDENTIALITY

- The **submission of the deliverables** is digital and must take place not over **12pm of 30 November 2021 (UTC/GMT +1)** through **Wetransfer** (<https://wetransfer.com/>) in a single folder or compressed file (.zip) containing all the elements of the proposal and showing as a name the competitor's **Alphanumeric Code**. - **Confidentiality:** competitors are required not to disclose any element of their proposal (images, reports, models or parts thereof) before the awarding of the winners.
